Visa Process for Indians

UAE:

- ✓ Employment visa: Employer sponsors — process takes 2-4 weeks
- ✓ Golden Visa: Available for specialized talent (5-10 year visa)
- ✓ No income tax — take-home equals gross salary

Singapore:

- ✓ Employment Pass (EP): minimum qualifying salary SGD 5,600+/month (SGD 6,200+ for financial services)
- ✓ Processing: 3-8 weeks, employer-sponsored
- ✓ Path to Permanent Residency after 2-3 years

UK:

- ✓ Skilled Worker Visa: Employer sponsors, finance roles qualify
- ✓ Minimum salary threshold applies
- ✓ ACCA/CIMA most recognized accounting qualifications

USA:

- ✓ H-1B Visa: Lottery system, employer-sponsored, 65K cap + 20K master's — note the steep new petition fee announced in late 2025 has made employer sponsorship more selective
- ✓ L-1: Intracompany transfer (easier if working for US firm in India)
- ✓ EB-2/EB-3: Green card pathway for skilled workers

Canada:

- ✓ Express Entry: Points-based, CFA/CPA give additional points
- ✓ Provincial Nominee Program (PNP): Some provinces fast-track finance professionals
- ✓ Processing: 6-12 months for PR

LinkedIn Optimization for International Roles

- ✓ Set location preference to target country in job preferences
- ✓ Headline: Include internationally recognized certifications (CFA, ACCA, CPA)
- ✓ Summary: Mention willingness to relocate and any visa eligibility
- ✓ Connect with recruiters in target country (search: 'finance recruiter [city]')
- ✓ Follow and engage with companies in target market
- ✓ Join country-specific finance professional groups

Which Certification Works Best Where

Country	Best Certs	Notes
UAE	CFA, ACCA	Both highly valued in Dubai/Abu Dhabi finance sector
Singapore	CFA, FRM	Strong demand for investment and risk professionals
UK	ACCA, CIMA, CFA	ACCA is the gold standard for accounting
USA	CPA, CFA	CPA is mandatory for accounting; CFA for investments
Canada	CPA Canada, CFA	CPA Canada or CA through MRA pathway
Australia	CA ANZ, CFA	CA ANZ through MRA with ICAI
Hong Kong	CFA, ACCA, HKICPA	Regional finance hub, CFA very valued

★ UAE offers the best net income (0% tax) and easiest visa process for Indian finance professionals. CFA + ACCA holders are in high demand in Dubai.

Relocation Preparation Checklist

6 Months Before Relocation

- ✓ Research target country's job market, cost of living, and visa requirements
- ✓ Start applying to jobs 4-6 months in advance — international hiring takes time
- ✓ Update LinkedIn to reflect international aspirations and certifications
- ✓ Connect with Indians already working in your target country/city
- ✓ Check if your certifications need local registration (e.g., CPA state licensure)

3 Months Before Relocation

- ✓ Begin visa application process (if employer-sponsored, coordinate with employer)
- ✓ Open an international bank account (HSBC, DBS, or Wise work well)
- ✓ Get credential evaluation done if required (WES, IQAS, NARIC)
- ✓ Research housing: Use websites like PropertyFinder (UAE), Rightmove (UK), 99.co (Singapore)
